#### Amazon.com Inc.

Complete Victory Against eBay, Inc.

"Amazon secured a major legal victory in its fight with rival eBay over seller poaching, with an arbitration panel ruling in its favor." (See "Amazon wins legal fight against eBay over alleged seller poaching," CNN, November 24, 2020.)

eBay asserted broad claims for fraud, civil RICO, breach of contract, tortious interference with contract, and violation of Washington's Consumer Protection Act, among others. eBay then broadly publicized its complaint and accusations. (See "eBay Accuses Amazon Managers of Conspiring to Poach Its Sellers," *The New York Times;* "eBay files lawsuit against Amazon over 'seller recruitment'" <u>BBC</u>, 2020.) After repeated COVID-19 testing and the creation of a Hueston Hennigan trial group bubble, the case went to trial in September 2020.

After a two-week trial, "the panel denied all of eBay's claims."



#### Internet Movie Database (IMDb.com)

#### IMDb Prevails at Ninth Circuit in Unanimous Opinion

The Ninth Circuit sided with IMDb in an important and closely watched First Amendment case. The Ninth Circuit affirmed the lower court's judgment that California's Assembly Bill 1687 (AB 1687) — which prohibited IMDb from publishing the ages of individuals in the entertainment industry — was an unconstitutional restraint on speech.



#### **Bausch Health Companies**

#### **Ninth Circuit Victory for Bausch Health**

Preserving Bausch Health's win in the trial court, we prevailed at the Ninth Circuit on behalf of the company in a significant trade secret and breach of contract case. We took over the case in early 2018 and aggressively moved to narrow discovery and bring the case to an end, winning a motion for judgment on the pleadings.



#### Freedom for Immigrants

### Immigrant Detention Hotline Featured in OITNB Restored

We won a preliminary injunction for Freedom for Immigrants (FFI), which ordered U.S. Immigration & Customs Enforcement (ICE) to restore FFI's National Immigration Detention Hotline featured in *Orange Is the New Black*. The hotline allows persons in immigration detention to report abuse and find resources, and bridges the divide between detained persons and their families.



#### **Navajo Nation**

### Eight-Figure Settlement After Multiple Victories

After multiple victories in the courtroom, we secured an eight-figure settlement for the Navajo Nation against one group of defendants in claims arising out of the unprecedented acid mine wastewater spill from the Gold King Mine near Silverton, Colorado. Our claims against the United States continue after the court held that the government could be liable for this environmental disaster.



#### **Houston Astros**

### Houston Astros Face Lawsuit in Wake of Alleged Cheating Scandal

We represent the MLB team Houston Astros, its owner Jim Crane, and Astros employee Derek Vigoa in defending against a multitude of tort claims asserted against them by Michael Bolsinger, a former pitcher for the Toronto Blue Jays. Bolsinger's claims arise out of Astros' purported "signstealing scheme" during the 2017 baseball season, when the Astros won the World Series.



#### Peloton Interactive, Inc.

### Peloton, Flywheel Settle Legal Disputes Over Fitness Bike

Following a series of courtroom victories, including defeating Flywheel's *Alice* challenge, we obtained a "massive win" for Peloton via settlement, including admissions of patent validity and intentional copying and an agreement to immediately cease using Peloton's patented leaderboard technology.

#### **Deloitte Consulting LLP**

#### **Complete Victory Secured in Qui Tam Lawsuit**

We represented Deloitte in a qui tam lawsuit brought by plaintiff Thomas Rocco, a former SAP employee, alleging that Deloitte Consulting and SAP had violated numerous conflict of interest laws and conspired to defraud the City of San Diego out of public funds.

#### BlackBerry Corp. and BlackBerry Ltd.

#### Victory in Civil Extortion and Unfair Competition Claims

We secured a victory for BlackBerry Corp. and BlackBerry Ltd. in civil extortion and unfair competition claims leveled against it by MobileIron, forcing it to pay BlackBerry's legal fees and drop its lawsuit.

#### **Fortune 500 Medical Technology Company**

#### **Closure of Global FCPA Investigation**

The SEC launched a broad 16-month global investigation of suspected violations of the Foreign Corrupt Practices Act. After a series of productions, proffered witnesses, and presentations, the SEC closed the investigation without taking any action.

#### **The Walt Disney Company**

#### **Multibillion-Dollar First-Impression Trademark Action**

We secured district court and court of appeal victories for Disney and 14 subsidiaries in this trademark action, seeking tens of millions of dollars in damages based on Disney's alleged copying of the "Lots of Hugs" trademark in the billion-dollar-grossing film *Toy Story 3*. The case presents a series of novel liability and damages issues that lie at the intersection of First Amendment law and the doctrine of reverse confusion.

#### Southern California Edison and PacifiCorp

### Public Utilities in California, Oregon, and Nevada Turn to Hueston Hennigan in Historic Fires

We are lead counsel to Southern California Edison and PacifiCorp in litigation arising out of the historic fires in California in 2017 and 2018 and Oregon in 2020.

### TOP LAWYERS # DECADE 2011-2020

### John C. Hueston

The go-to strategist for high-stakes trials and complex civil litigation

he stakes were high when Hueston defended Tesla Inc.
CEO Elon Musk after the U.S. Securities and Exchange Commission moved to hold him in contempt and sanction him for tweeting about his company's capacity to produce half a million cars in 2019, allegedly violating a prior agreement with regulators.

"Many analysts predicted that Musk would be removed as CEO," Hueston said of the case in the Southern District of New York that began with the SEC's claim that Musk misled investors in earlier tweets. Following Hueston's arguments, the judge set aside the government's contempt request; the SEC redrafted its oversight order. Musk remained in the executive suite. "We got what we wanted," Hueston said. SEC v. Musk, 18-cv-08865 (S.D. N.Y., filed Sept. 27, 2018).

"This was a unique First Amendment case," he added. "What can a CEO say and not say? When the president of the United States tweets his every thought, how can a CEO not? We caught the SEC out of its jurisdiction, and they knew it. We helped define the landscape of executive speech and governance."

Success at the highest levels of business law has become routine for Hueston, who represents Fortune 500 companies as lead counsel in their most challenging and high-profile cases and investigations. His client roster includes Amazon.com Inc., Deloitte Touche Tohmatsu Ltd., Edison International, Qualcomm Inc., T-Mobile, The Walt Disney Co., PricewaterhouseCoopers, the Navajo Nation, Whole Foods Market Inc. and others.

And from the time he successfully promoted his Ivy League college's divestiture from South Africa as part of the anti-apartheid movement, he and the firm he cofounded have stressed a public service component to their work. The Los Angeles Center for Law and Justice named Hueston Hennigan its 2016 Pro Bono Partner of the Year.

Some cases combine tough business litigation with benefits that go beyond the bottom line. Hueston is proud of the case that produced a \$5.15 billion settlement for environmental cleanup after Anadarko Petroleum Corp. moved to acquire energy giant Kerr-McGee Corp. They tried to shelter existing liabilities in a spin-off shell company, Tronox Ltd., including the toxic messes left across the U.S from wood-processing, uranium mining and rocket fuel production. Appointed by the U.S. Department of Justice to represent the Anadarko Litigation Trust, Hueston achieved the deal after a 34-day trial in what was the nation's largest environmental fraudulent transfer

case. A bankruptcy judge's pivotal fraud finding against Kerr-McGee forced the settlement. *Tronox Inc. v. Anadarko Petroleum Corp.*, 09-1198 (S.D. N.Y. Bankruptcy Ct., filed Jan. 12, 2009).

"We had to win at trial because they wouldn't settle," Hueston said. "The judge's opinion brought the defense to the table and enabled full remediation across the U.S. It was one of those cases where you feel you have done something good for your country and deterred that kind of behavior in the future. More than \$1 billion went to the Navajo Nation" to clean up abandoned uranium mines on their land. Hueston went on to further represent the Navajo Nation's interests in the disastrous Gold King mine spill in Utah. State of *Utah v. Environmental Restoration LLC*, 2:17-cv-00866 (D. Utah, filed July 31, 2017).

Hueston and Brian J. Hennigan formed their trial law boutique in 2015 after working together at Irell & Manella LLP. Most recently, in December 2020, Hueston obtained a complete defense verdict for Amazon.com before an arbitration panel after rival eBay Inc. sued over claims of seller poaching. *eBay Inc. v. Amazon.com Inc.*, 18-cv-336315 (S. Clara Co. Super. Ct., filed Oct. 17, 2018).

"We completely reversed the narrative of a plaintiff trying to smear a competitor," Hueston said. "We erased the stain. And as a firm we took further our theme of successful showdowns at trial."
